- Retired military
- Non-military police
- Foreign active-duty military personnel who live in the Washington, DC metropolitan area

FOREIGN MILITARY PERSONNEL WHO LIVE OUTSIDE OF THE UNITED STATES MUST CONTACT THE OFFICE OF MILITARY COOPERATION (MILGROUP) AT THE US EMBASSY IN THEIR COUNTRY TO APPLY.

Essay Question 1:

Please describe current role(s) and responsibilities you have at your job, your organization's mission in relation to security and/or defense.



Essay Question 2:

Outline the major human rights challenges faced by your organization and what is being done to address them or describe the most significant human rights accomplishment achieved in your country or organization in the past decade.

- Passport / Visa Information
 - Copy of a valid passport and visa; if you do not have one (or both), provide the date you
 expect to receive your documents.
 - o If you are a civilian government employee applying as a self-nominee, you will not be able to use your official passport. You must use a personal passport and visa.
- Two (2) letters of recommendation
 - One of the letters must be from your supervisor / chain of command.
 - Both letters should specifically indicate what you would be contributing to the course, and what benefits you and/or your organization would derive from your attendance, should you be selected to participate.
 - o Both letters must be dated no earlier than 60 days before your actual application date.
 - o Individuals who are independent contractors or sole proprietors must still submit two letters of recommendation from professional references addressing the above points.
 - o Both letters should be addressed to the Director of the William J. Perry Center for Hemispheric Defense Studies.
- Professional Experience Form (available for download directly below). The form must be completed fully. DO NOT ATTACH a copy of your own CV in lieu of completing the form:
